### Background

ECP-2 is the second stage of the CRU's development of enduring connection policy in Ireland. On the 10<sup>th</sup> June 2020 the CRU published their decision on ECP-2, which set policy for at least three annual batches of connection offers (ECP 2.1, ECP-2.2, and ECP-2.3). Subsequently, the CRU published their decision on ECP-2.4, which set policy for an additional batch of connection offers (ECP-2.4).

ESB Networks have used the ECP-2 decision paper<sup>1</sup>, subsequent ruleset<sup>2</sup> and ECP-2.4 decision paper<sup>3</sup> to determine which Category B and Category C applicants have been successful in making the list of projects due to receive connection offers in the ECP-2.4 Batch.

This report contains the list of ECP-2.4 applicants processed under Category B and Category C as per the ECP-2 Decision Paper.

The CRU has decided that for ECP-2, there should be a possible connection pathway for specific sub-categories of projects to be connected outside the framework of the batch process.

The non-batch category B was open to the following projects:

- Small projects i.e. MEC greater than 6kW/11kW and less than or equal to 500kW
- DS3 system services trial projects up to 500kW; and
- Autoproducers

The non-batch category C was open to the following projects:

100% community- owned projects where MEC greater than 0.5MW and less than or equal to 5MW
