



## Enduring Connection Policy - 2.1 (ECP-2.1) 2020 Non-Batch Category B & Category C

## Background

ECP-2 is the second stage of the CRU's development of enduring connection policy in Ireland. On the 10<sup>th</sup> June 2020 the CRU published their decision on ECP-2, which set policy for at least three annual batches of connection offers (ECP 2.1, ECP-2.2, and ECP-2.3).

ESB Networks have used the ECP-2 decision paper<sup>1</sup> and subsequent ruleset<sup>2</sup> to determine which Category B and Category C applicants have been successful in making the list of projects due to receive connection offers in the ECP-2.1 Batch.

This report contains the list of applicants that will be processed under the Category B and Category C as per the ECP-2 Decision Paper.

The CRU has decided that for ECP-2, there should be a possible connection pathway for specific sub-categories of projects to be connected outside the framework of the batch process.

The non-batch category B was open to the following projects:

- Small projects i.e. MEC greater than 6kW/11kW and less than or equal to 500kW
- DS3 system services trial projects - up to 500kW; and
- Autoproducers

The non-batch category C was open to the following projects:

- Community-Led Projects where MEC greater than 0.5MW and less than or equal to 5MW

Category C consists of Community-led Projects with MEC  $\geq$  0.5MW and  $\leq$  5 MW. Applicants are not required to have planning permission but will be prioritised by planning permission grant date and then by application form Received Complete Date. The SOs will target 15 community-led project connection assessments per batch period. If category B is undersubscribed its unused allocation will be reallocated for use by additional projects from category C (and vice versa). There will be no reallocation of projects from category A to categories B or C (and vice versa).
