RE: Standard Connection Agreement for Connection to the Electricity Distribution System.

Dear Sir/Madam,

ESB Networks Limited builds, operates and maintains the electricity Distribution System throughout the Republic of Ireland. We connect all customers to the Electricity Distribution System, regardless of chosen Electricity Supplier. As the registered Electricity User at connection point [GV_MPRN], ESB Networks also welcomes you as a user of the Electricity Distribution System and a customer of ESB Networks Ltd.

It is a condition of being connected to the Electrical Distribution System that you accept the terms and conditions under which a connection to the Electricity Distribution System is provided, from the date that your connection was provided. Use by you or another person (whether or not such a person is acting with your authority) of this connection provided by ESB Networks Ltd is deemed to be acceptance of terms and conditions under which a connection to the Electricity Distribution System is provided. These terms and conditions include:-

- The 'General Conditions for Connection of Industrial and Commercial Customers and Generators to the Distribution System' (hereinafter referred to as the "General Conditions")#
- Standard Connection Agreement
- The Distribution Code#

I enclose a Standard Connection Agreement number [GV_NOTIFNUM2]. This agreement is a standard document with a number of site-specific details added, which are based on requirements previously submitted to ESB Networks Ltd, at time of first connection or by a previous occupant of your premises.

For your assistance, a number of important details are highlighted in the explanatory notes below and it is important that these satisfy your requirements.

Note:

Clauses 4.0, 6.0 and Appendix 1 of the Standard Connection Agreement refer to works required for new and increased connections therefore these clauses are not applicable in all cases.

Interface Undertaking:

ESB Networks Ltd, in accordance with the terms of Clause 3 of the Operating Agreement (dated 22 December 2008 between ESB Networks Ltd and ESB), is required to ensure that the Customer gives and maintains an Interface Undertaking to ESB Networks Ltd for the propose of ensuring that the legitimate interests of ESB as Distribution Asset Owner are protected. I would like to draw your attention to the Interface Undertaking at Schedule 4 of the enclosed Standard Connection Agreement. Use by you of this connection is deemed to the acceptance of the Interface Undertaking.

Notes on Confirming Your Site Specific Details:

Address Please check that the Registered Office Address is correct.

Schedule 1 Please check that the *Maximum Import Capacity* level is satisfactory to you.

Schedule 1 Please confirm the contact name and telephone number are correct.

Schedule 2 Please provide the name and position of the people to whom you wish us to send any notices.

Your Meter Point Reference Number (MPRN) is an important number which was assigned to the connection point in your premises at time of connection. It will be needed when contacting ESB Networks or should you wish to change electricity supplier in the future.

The **Maximum Import Capacity** (MIC) is the capacity which ESB Networks commits itself to maintain available to your premises at the connection point according to your requirements. Please note the MIC places an upper limit on the total electrical demand you can place on the Electricity Distribution System. Secondly, it forms the basis of capacity charges in your electricity bill. MIC is measured in kilo-Volt Amperes (kVA).

However it is advisable to seek independent technical advice in order to ensure that the connection for which you have registered, as described in Schedule 1 of the attached Standard Connection Agreement meets and will continue to meet your requirements

NOTE: THE MIC WILL DETERMINE CAPACITY CHARGES IN YOUR ELECTRICITY BILL. CHECK THAT YOUR MIC LEVEL IS CORRECT FOR YOUR ELECTRICITY NEEDS.

If, having sought independent technical advice, you wish to change any of the details in Schedule 1 of the attached Standard Connection Agreement, you should make a written application to ESB Networks Ltd, by means of an application form, stating what changes are required. Please note that any changes will be subject to a quotation and acceptance by you of a revised Standard Connection Agreement.

If any of your Company's address or contact information contained in this agreement is incorrect please contact your Electricity Supplier or ESB Networks Ltd to discuss alterations as soon as possible.
