Extract from Existing Distribution Code to add review of above proposed modification

DOC11.6 SAFETY RULES

- DOC11.6.1 **Operation** and maintenance of the **Users' Equipment** shall only be carried out by authorised personnel. Before first **Commissioning** the **Plant**, operating procedures shall be agreed with the **DSO**.
- DOC11.6.2 Instructions for operating and / or **Earthing** the **Users' electrical Equipment** shall be clearly displayed in the **Users' Medium** and **High Voltage** switch room.
- DOC11.6.3 The **ESB Networks Electrical Safety Rules** detail the **Safety Procedures** to be observed for all personnel working on or in close proximity to **Distribution System Plant** or **Equipment**.

Existing Definitions in Distribution Code:

- Safety Management** The procedure adopted by the **DSO** or a **User** to ensure the safe **Operation** of its system and the safety of personnel required to work on that system.

- Safety Procedures** The procedures specified within a **Safety Management** system.
